- Current employment / student assistant contract and/or certificate of the employer relating
- to current or terminated activities, if available
- 8. Current rental contract for the apartment
- 9. Proof of **four** attempts to obtain financial support (job rejection letters, scholarships, financial aids, credits, ...) from the **last three months**
